he Second Vatican Council provided the impetus for the People of God to become more actively involved in various ministries of the Catholic Church. Among those ministries is participating more actively on Catholic



Considerations

- The board accepts the challenge of becoming a significant partner with the administration and those with the final say in the ministry of education by ensuring that the school retains its Catholic identity and its value for the clients it serves.
- The board participates with the administration and those with the final say in developing and promoting a shared vision for the school, its programs, and its students and graduates.
- The board, in collaboration with the administrators and those with the final say, takes a leadership role in ensuring the success of all school programs and endeavors.
- The board internalizes and accepts the respective roles and responsibilities of the one with the final authority (pastor, bishop, head of religious order), the administration, and the board in the operation of the school.

- The board affirms and supports the administrators as they carry out their responsibilities in the school community.
- The board takes a leadership role in promoting and developing a Catholic school family of believers who reflect a community of faith.
- The board puts into place the committees, the processes, and the procedures to best carry out the deliberations and activities of a Catholic school board.
- The board develops a program and a process that ensure financial stability for the school.



- The board writes and updates policies that guide the operation of the school, which are promulgated by the appropriate authority.
- The board agrees that in-service, selfgrowth programs enable the board members, individually and as a group, to perform effectively and efficiently.
- Board members commit themselves to attend all in-service programs planned by the board.
- Board members should be exemplars of a good Christian life and good citizenship.

Internalize Considerations

The board and its members need to make and take the time—in a retreat setting—to explore, to discuss, to accept, and to internalize the above considerations and others that may emerge. It is important that board members are in agreement, individually and as a group, so that in principle and in practice the board speaks with one voice and moves in a unified direction in its deliberations and in its actions.

Review Constitution

Now is not the time for each of the considerations listed above to be fleshed out. Rather, at this time, in concert with the administration and those with the final say, the board should determine if the Considerations describe what our Catholic school board should be doing. The next step should be to review the constitution and/or bylaws to determine if the document reflects and embodies the characteristics of a Catholic school board in
